



Zone B concession regulations

Waters under concession:

- Fiumicello Brendola: from the springs in the municipality of Brendola downstream to the river in Lonigo;
- Guà River: from the confluence with the Brendola River downstream to the border of the province;
- Scolo Liona, for its entire course, including the expansion basin of Villa del Ferro;
- Lake Fimon and emissary (Canale Nuovo) for its entire course;
- Ferrara Canal, Scolo Marzia and Debba Canal for their entire course;
- Canale Bisatto: from its origins to its entire course;
- Retrone River: From the confluence of the Onte and Valdiezza streams to the confluence with the Bacchiglione;
- Bacchiglione River: From the bridge of Via dello Stadio in Vicenza to the borders of the province of Padua;
- Tesina River: from the Marola Bridge downstream for its entire course in zone B;
- Roggia Tribolo: from the bridge of Via Cà Balbi in Vicenza downstream to the confluence with the Tesina;
- Ceresone River: From the bridge of Via Torrossa in the municipality of Camisano Vicentino downstream to the border with the province of Padua;
- Canale Cordano: From the springs in Valli di Sant'Agostino to the confluence with the Retrone in Vicenza

Membership fees and registration procedures: In order to be able to fish in the waters under concession, the fisherman must be in possession of proof of payment of the membership fee (for the year 2024 fixed in Euro 40.00) in the postal current account no. 12536306 in the name of Bacino di pesca zona B – Via Muggia, 14- Vicenza. Bulletins can be found at fishing shops. Children under the age of 14 They will be able to fish in the waters under concession even without having paid the membership fee.

No Kill Zones: Fishing with artificial lures (excluding silicone baits) is allowed in these zones Equip yourself with a single barbless dart and the use of a landing net is mandatory. Each catch will have to be immediately released.

- Retrone River: in the stretch that flows in the municipality of Creazzo between the bridge of the SP 35 and the bridge of the SR 11;
- Roggia Tribolo: from the bridge of Via Cà Balbi in Vicenza downstream to the confluence with the Tesina;

Specific No Kill Zones: The Fish Charter has established the following specific NO KILL zones: retain all native and para-native fish species.

- Ceresone River: from the Torrerosa bridge to the municipal border between Camisano and Grisignano;
- Fosso or Scolo Liona: the entire route;
- Tesina River: the entire concession section from the beginning of zone B to the end of the section;
- All watercourses affected by PFOS that flow in the municipalities of Agugliaro, Alonte, Asigliano Veneto, Brendola, Lonigo (VI), Noventa Vicentina, Orgiano, Pojana Maggiore, Sarego, Val Liona;

Prohibited areas in waters free from concession constraints that flow, in whole or in part, in zone B:

- Valdiezza stream: for the entire route in zone A and zone B; zone A and zone B);
- Bacchiglione River: in Colzè, in the entire bend that includes the passage for fish and the lock;

Prohibition zones:

- Ferrara canal from the source downstream to the derivation of the Marzia drain.
- Bacchiglione River in Colzè in the stretch between 10 meters downstream and 10 meters upstream of the Fish ascent.

Special rules for fishing in the waters of Lake Fimon, also provided for in [the Regulations for the management of Lake Fimon](#)

- Carp fishing is allowed only from the pitches, from sunset at dawn, without prejudice to the operations of positioning bait and lines and setting sail, which may be pipelines with the use of boats;
- Fishing from boats or belly boats is forbidden from dusk to dawn;
- It is forbidden to use the Carp Sack;
- Flaggers in the groundbait areas must have a tag with the personal data and address of the fisherman and must be removed before leaving the fishing site;
- Baiting is allowed only with boilies;
- Each fisherman may keep and use a maximum quantity of 250 g of corn as bait;
- Please note that the use of life jackets is mandatory when using the boat;

Special rules for the whole Basin

The use of live or dead fish as bait is forbidden throughout the Basin.

It is **forbidden to retain carp catches** and any catches must be promptly returned to the water, using every precaution during unhooking operations.

It is mandatory to use a steel cable with a minimum length of cm. 20 in fisheries with hooks equipped with several barbs (treble hooks and the like).

In the expansion basin of Villa del Ferro (San Germano lake) the use of the belly boat is allowed and it is Fishing from boats is prohibited.
